

Quick Guide: Subprocessors

Background

Subject to the instruction of a customer, Coupa Software, Inc. ("*Coupa*") hosts a customer instance either in the Europe Economic Area, United States of America, or as otherwise agreed. In the course of providing services on the Coupa Platform, Coupa personnel located outside of the selected hosting region may require access to customer data.

In addition, Coupa and its affiliates engage third-party contractors and suppliers in the context of the provision of the Coupa Platform and selected Hosted Applications ("*Third-Party Suppliers*"). Some of these Third-Party Suppliers may have access to, and process, customer data, including customer personal data ("*Subprocessors*").

This quick guide shall provide you with an overview on the various Subprocessors currently used by Coupa in the performance of the Coupa services. Please note that the specific details of Subprocessors used for each customer depends on the individual subscription scope and configuration. This quick guide is subject to change.
